HOW TO DONATE

If you have not activated an account with the Illinois Department of Revenue, you will need to:

- 1. Request Letter ID (page 1)
- 2. Activate Your Account (page 2)
- 3. Reserve Your Credit (page 4)
- 4. Make Your Donation (page 8)

If you have activated an account with the Illinois Department of Revenue, please skip to page 4.

REQUEST LETTER ID

- 1. Log on to mytax.illinois.gov.
 - If you already have an account, enter your username and password to verify.
 - If you do NOT have an account, scroll down to the 'Individuals' box on the left.
- 2. Click on 'Request a Letter ID."

3. Enter your Social Security Number and one of the following:

- IL-PIN
- Most Recent Adjusted Gross Income IL
- Driver's License Number
- IL State Identification Number
- 4. Click 'Submit' and enter and confirm your email address; then click 'OK' to submit and receive your confirmation.
- 5. Your Letter ID will be mailed to the address on your last year's tax return. You should receive it within 7-10 business days.

- 6. Log on to mytax.illinois.gov and click 'Sign Up.'
- 7. Select SSN, enter your Social Security Number and click submit; then click 'Yes' to begin activating your account.
 - Enter your Letter ID and either your Individual IL Pin or your most recent Adjusted Gross Income (AGI). If you choose your IL PIN, click on 'Look Up My IL PIN' and go to Step 8. If you choose your most recent AGI, go directly to Step 9.

- 9. Enter your Letter ID and your IL PIN. When the screen expands, enter:
 - Your contact information
 - A username and password
 - A security question and answer
- 10. Click 'OK' on the next screen. You will receive email confirmation that your account was activated.

RESERVE YOUR CREDIT

Only donors who have activated an account with the Illinois Department of Revenue will be able to reserve a Tax Credit. If you have a Username from a previous year, log in using that Username and Password. If you cannot access your account, contact IDOR at 800–732–8866 to resolve this issue. If this is your first time logging into your account after creating it, you will need to enter the Activation Code you received from IDOR after your account was created.

Please make sure the name on your CAC matches the name on the bank or credit card account from which the donation is being drawn. As a reminder, under the Invest in Kids Act, corporate donors are not permitted to designate tax credit scholarship donations.

- 12. If you have not already, set up two-step verification for your account. Add your email address and enter the security code sent to you.

FILE TAXES AND RECEIVE YOUR CREDIT

- 1. In order to file and claim your Invest in Kids Tax Credit, you will need to submit IL 2022 Schedule 1299–C. If you are filing by mail, you must submit all three pages of your 1299–C.
 - Enter the information in Lines 21-41 on the IL Schedule 1299-C form as follows:
 - Column A: Years Left to Carry -> 5 (This number may vary by individual if you are carrying forward credits from previous years.)
 - Column B: Credit Code -> 5660 Invest in Kids
 - Column C: IL Tax Year Credit Earned -> 2022
 - Column D: Identifying Number -> Enter the certificate number from your Invest in Kids Certificate of Receipt.
 - Column E: Credit Earned or Carried -> Enter your tax credit amount. (This number equals 75% of your donation.)
 - Column G: Total Credit -> Enter credit amount again.
 - Column I: Credit Applied -> Enter the total credit you will be applying to this tax year.
 - Column J: Credit Carried Forward -> Enter credit amount you will be carrying over into the next year or beyond.

2. Find your certificate of receipt.

- Log into your MyTax Illinois account.
- Click "Correspondence."
- Click "View Letters" in the Unread Letters column.
- Select "Invest in Kids Cert of Receipt."
